The stock short name of the Company will be changed from “ZH INT'L HOLD” in English and “正恒國際控股” in Chinese to “ZENSUN ENT” in English and “正商實業” in Chinese, for trading in the Shares on the Stock Exchange with effect from 9:00 a.m. on 15 July 2019. The stock code of the Company on the Stock Exchange will remain unchanged as “0185”.

The Board is pleased to announce that, following the approval of the Proposed Change of Company Name by the Shareholders by way of special resolution at the EGM, the Registrar of Companies in Hong Kong has issued the certificate of change of name dated 8 July 2019 confirming that the change of name of the Company from “ZH International Holdings Limited 正恒國際控股有限公司” to “Zensun Enterprises Limited 正商實業有限公司” has become effective on 8 July 2019.

CHANGE OF STOCK SHORT NAME

The stock short name of the Company will be changed from “ZH INT’L HOLD” in English and “正恒國際控股” in Chinese to “ZENSUN ENT” in English and “正商實業” in Chinese for trading in the Shares on the Stock Exchange with effect from 9:00 a.m. on 15 July 2019. The stock code of the Company on the Stock Exchange will remain unchanged as “0185”.

EFFECT ON PROPOSED CHANGE OF COMPANY NAME

The Proposed Change of Company Name will not affect any of the rights of the Shareholders. All existing share certificates of the Company in issue bearing the previous name of the Company will continue to be evidence of title to Shares and will remain to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing share certificates for new share certificates bearing the new name of the Company. New share certificates of the Company will be issued in the new name of the Company with effect from 15 July 2019.
