Xinzheng City Natural Resources And Planning Bureau, being the seller of the Land Parcel is a PRC Governmental body and is responsible for, among other things, administering the examination and approval of land planning, assignment and transfer of the land use rights of the state-owned land in Xinzheng City, Henan Province, the PRC and the issue of various types of land certificates.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, Xinzheng City Natural Resources And Planning Bureau and its beneficial owner are third parties independent of the Group and its connected persons.

The Company and its subsidiaries (collectively "**Group**") are principally engaged in property development, property investment, project management and sales services and securities trading and investment.
