POLL RESULTS OF EXTRAORDINARY GENERAL MEETING

The Board is pleased to announce that the ordinary resolution proposed at the EGM held on 2 September, 2010 was duly passed by way of poll.

Reference is made to the announcement of Xpress Group Limited (the “Company”) dated 6 August 2010 and the circular issued by the Company dated 17 August 2010 (the “Circular”). Terms defined in the Circular shall have the same meanings when used herein unless the context requires otherwise.

The Board is pleased to announce the poll results in respect of the ordinary resolution proposed at the extraordinary general meeting of the Company (the “EGM”) held on 2 September 2010 as set out in the notice of the EGM dated 17 August 2010 as follows:

As more than 50% of the votes were cast in favour of the ordinary resolution proposed at the EGM, and such resolution was duly passed.

As at the date of the EGM, the total number of issued shares of the Company was 2,640,836,050. Mr. Chan and his associates and all connected persons of the

Company held in aggregate 1,779,516,964 shares of the Company (representing approximately 67.38% of the issued share capital of the Company as at the date of the EGM), and had abstained from voting on the ordinary resolution at the EGM. No other shareholders have stated their intention in the Circular to abstain from voting at the EGM. To the best of the directors' knowledge and belief after having made all reasonable enquiries, other than Mr. Chan and his associates, no other shareholders have a material interest in the ordinary resolution.

Accordingly, the total number of shares entitling the shareholders of the Company to attend and vote for or against the ordinary resolution was 861,319,086 shares (representing approximately 32.62% of the issued share capital of the Company as at the date of the EGM). No shareholders were entitled to attend and vote only against the ordinary resolution at the EGM. No shareholders have stated their intention in the Circular to vote against the ordinary resolution at the EGM.

Tricor Friendly Limited, the Company's share registrars, acted as the scrutineer for the vote-taking at the EGM.
